BUDGET & FINANCIALS

Our account balance as of May 25, 2022 is CAD \$10,264.74. Our membership contribution is CAD \$35 per person. Currently we have a recurring monthly expense of CAD \$19 for banking with TD Canada Trust. As of now, we have a balance budget.

A request has been made to EERI Central to support the EERI-BC webpage.
